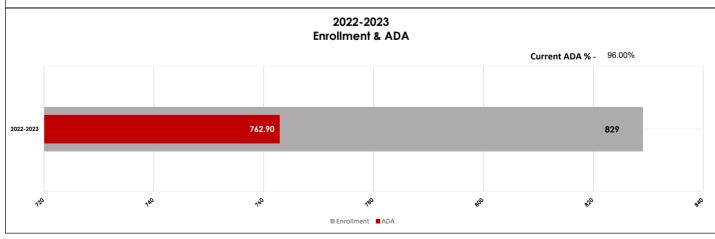


Revenues & Expenditures As of March 31, 2023

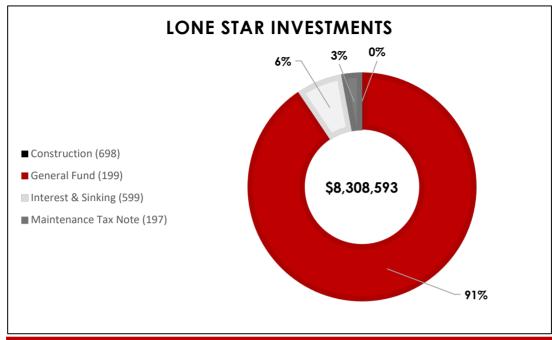
